

CONSENT TO THE PROCESSING OF PERSONAL DATA

I consent to the use of my personal data for the following purposes:

- ensuring compliance with the requirements of the legislation of the Russian Federation;
- provision and monitoring of the educational process;
- issuing training certificates;
- transfer of information to federal and regional information systems in order to ensure that: implementation of procedures for assessing the quality of education – independent diagnostics, monitoring procedures, etc. research, maintaining the federal register of information on educational and / or qualification documents, and training documents (in accordance with Decree of the Government of the Russian Federation No. 729 of August 26, 2013);

- submission of statutory reports on individuals to the Federal Tax Service and extra-budgetary funds;

- video recording of the territory of the educational institution to ensure anti-terrorist protection/prevention of illegal actions;
- posting a photo image on the official website of KemSMU of the Ministry of Health of the Russian Federation (kemsmu.ru), social networks and information stands in the framework of the educational process, extracurricular activities, sports competitions, and other significant events held by the educational organization;
- providing information for issuing a travel ticket.

List of personal data that consent is given for processing:

- last name, first name, patronymic;
- gender and age.
- year, month, date and place of birth.
- certificate of citizenship (if necessary);
- details of the identity document;
- taxpayer identification number, date of registration, details of the certificate of registration with the tax authority;
- number of the compulsory pension insurance certificate, date of registration in the compulsory pension insurance system;
- documents containing medical reports (preliminary(periodic) medical examination report, ITU certificate, fluorography);
- address of the actual place of residence and registration at the place of residence and (or) at the place of stay;
- postal and email addresses.
- phone numbers.
- photos.
- information on education, profession, specialty and qualification, professional training, information on advanced training, documents on awarding a scientific degree or scientific title;
- information about the marital status and composition of the family;
- information about military service, military registration;
- photo of the graph.

A list of actions with personal data that consent is given for, and a general description of the methods of processing personal data used by the operator:

The processing of the above-mentioned personal data will be carried out through mixed (automated, non -automated) processing of personal data.

Collection, recording, systematization, accumulation, storage, clarification (updating, modification), modification, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.

The period during which the consent of the personal data subject is valid, as well as the method of revocation thereof, unless otherwise established by federal law;

This consent to the processing of personal data is valid from the moment it is submitted to the operator and can be revoked by me at any time by submitting a simple written application to the operator.

Personal data of the subject is subject to storage within the time limits established by the legislation of the Russian Federation. Personal data is destroyed: upon achievement of the purposes of personal data processing; upon liquidation or reorganization of the operator; on the basis of a written request from the personal data subject with a request to stop processing his / her personal data (the operator will stop processing such personal data within 3 (three) business days, and a written notification will be sent to the personal data subject within 10 (ten) business days.

It was explained to me that revocation of this consent may make it difficult or impossible to resume processing of personal data and confirm them.
